Special note: Since even singers who will not be singing with CMS for part or all of the 2019-2020 season will be permitted and encouraged to join the tour chorus next summer, we are asking for some additional information. Rehearsals will be April 27, May 4, 11, 18, 26 (the only Tuesday rehearsal), and June 1, 8, 15 and 22 with a pre-tour performance on Sunday afternoon, June 21. The June 22 rehearsal is mandatory, and only one absence is permitted in the sequence. Participation in the June 21 performance is not mandatory but is strongly encouraged.

—**Full tour package including flight** (per person/double occupancy) = **\$4,050***

**An estimate of the cost of airline taxes and fuel surcharges is included in this price; once those final costs are determined, the final payment will be adjusted accordingly, up or down. In addition, prices are based on bus occupancy of 40 per bus and will be adjusted upward if enrollment is below that threshold.*

— **Land Only** (per person/double occupancy; self-purchased airfare) = **\$2,740**

Schedule of Payments We will distribute the payment schedule with the remaining specific amounts very shortly. For now, we can tell you that the due dates are as follows: First payment (\$250 deposit) due September 9, 2019; second payment due October 28, 2019; third payment due February 3, 2020; final payment due May 18, 2020. Each of the three final payments will be approximately 1/3 of the overall cost.

Payments will be collected at the CMS rehearsals matching the deadline dates listed above. (Exception: we will begin collecting the \$250 deposits at the tour meetings on September 3 with the final collection, especially for new singers, on September 9.) All non-singers and those singers who will not be present at those rehearsals should mail their checks to arrive by those dates. Please see mailing instructions below.
